JOHN CASE (c15 Feb 1789 – 1815-1828) m 25 April 1813 at Corscombe Parish Church, to **HESTER TUCKER** (c1790 – 20 Sept 1860 at Broadminster, aged 70 years)

JOHN CASE, son of Ann Case and James Cleall Baptised, 15 Feb 1789 at Corscombe, Dorset, England.

[Hester Case, nee Tucker, widow, married(2) 26 Oct 1829, at Beaminster, to **SAMUEL RENDLE** (c1773 – c14 Feb 1850, at Beaminster, aged 77 years) Samuel Rendle's first wife could have been **MARTHA** buried 1 Oct 1824, aged 48 years.

- 1 1 **NATHANIAL CASE** (Bapt 9 March 1814 at Beaminster - 11 Jan 1829 at Beaminster), aged 14 years. Interred 15 Jan.
- 1 2 **EMANUAL CASE** (Bapt 13 Nov 1815 - 1 Aug 1898) arrived in South Australia on the *Canton* on 2 May 1838 and was living in the area south of Adelaide in 1841. m 6 Nov 1844 (probably at Wakefield Street, Adelaide) to **JANE STARS** (c1827 – 25 May 1893) She was dau of Peter & Catherine Stars of Little Para, and had arrived in South Australia on the *Dauntless* on 10 July 1840. (Mrs Murray says she was born in Fintona. Co Tyrone c1821 – 25 and arrived with her parents, Peter and Catherine Stars and brother, Francis and sisters Ann(e), Catherine and Ellen), having sailed from Greenock, Scotland.
- EMMANUEL CASE** was given Embarkation No. 471. 13 June 1836, was an agricultural labourer of Beaminster, Dorset, aged 18 years. Engaged by Mr Hallett, but was ill and unable to go. New Embarkation No. 947, 9 Dec 1837 No. 1675 Agricultural laborer, on the *Canton*. The *Canton* sailed from Gravesend 15 Dec 1837, arrived at Kangaroo Island 30 April 1838 and at Adelaide 2 May 1838, with 143 passengers; Captain J. Mordaunt.

The Kelly family details as taken from Frank Clune's book *The Kelly Hunters*, published 1954 by Angus & Robertson.

SEAN CEALLAIGH [JOHN KELLY] baptised 20 Feb 1820 son of THOMAS KELLY of CLONBROGAN, near MOYGLASS Co TIPPERARY, IRELAND and HIS WIFE MARY CODY [a kinswoman -possibly an aunt of William Frederick Cody BUFFALO BILL who was born in Iowa U.S.A. on 26 Feb 1846]. Thomas Kelly and Mary Cody had married at Moyglass on 1 Feb 1819. Other children of this marriage, whose details are in the parish registers of Killenaule:

EDMOND baptized 10 July 1822.
THOMAS baptized 14 November 1825
MARY baptized 2 November 1828
ANNE baptized 16 July 1831
JAMES baptized 30 August 1835 and
DANIEL baptized on 3 Feb 1839.

The mother Mary (nee Cody) is believed to have come from the parish of Gambonsfield, which is twelve miles south of Clonbrogan.

JOHN KELLY was charged with pig stealing from a prosperous farmer, found guilty by a jury and sentenced to seven years transportation. He was a convict passenger on the ship *Prince Regent* which sailed from Dublin on 7 August 1841 together with 181 fellow male convicts, and arrived in the Derwent River on 2 Jan 1842. He was granted a ticket-of-leave on 11 July 1845 and granted expiation of his sentence on 1 Jan 1848.

JAMES QUINN and his wife MARY (nee McGLUSKY) arrived on the ship *ENGLAND* on 18 July 1841 at Port Phillip Bay. There were six children born in Antrim, Northern Ireland,

PATRICK (b 1826, and drowned at Echuca in 1850).

JOHN (b 1831)
ELLEN (NELLY) (born 1832), married JOHN KELLY
CATHERINE (b 1833/4).
JANE (b 1837)
JAMES (b Jan? 1841),
